# Employment History & Professional Experience: June 2007 to present - Director, SocietyInside (previously MATTER & Responsible Nano Forum)

UK based not-for-profit organisation dedicated to making new technologies work for us all. Aims to build a bridge between science, technology and society by focusing on three main areas: (a) embedding good governance, (b) promoting the involvement of the public and other stakeholders and (c) inspiring the development and use of new technologies for societal benefit.

Work initially focussed on nanotechnologies though recently broadened to encompass more general governance social and ethical areas of science and technology - Responsible Research and Innovation - and other specific technologies, including synthetic biology, robotics, Artificial Intelligence, quantum technologies, biotechnology and converging technologies and their applications.

Co-developing a Framework for Meaningful Engagement, Stakeholder Engagement by Impact and Prompt Sheet for Al Human Rights Impact Assessment with the European Centre for Not-for-profit Law, Netherlands.

External advisor to Ireland's Heath Service Executive on Trust, including public engagement, communications and measurement of trust.

There is much discussion about trust in technology but very little about how the governance itself can be designed to better earn societal and political trust. This initiative brings together learning on governance, trust and distrust and the insights of psychology, sociology and behavioural insights to explore how governance can become more trustworthy and trusted.

Developed influential Principles for Responsible Innovation, which evolved from an initiative I created which was funded by the Royal Society & Insight Investment - The Responsible Nano Code. This thinking has influenced organisations as diverse as Ecover (ethical cleaning company), the University of Sheffield and the World Economic Forum. Invited to produce a seminal text for the European Commission in 2011, an accessible exploration of the new field of Responsible Research and Innovation, including evolving definitions - An Introduction to Responsible Research and Innovation.
